 and regional authorities in the EU development policy; be the contact point for EU institutions and
 other stakeholders regarding EU external action;
- Representation of PLATFORMA at the Policy Forum on Development: actively contribute to the Task
 Team and the overall work of the PFD together with the director of PLATFORMA, and support the
 secretary general of CEMR as co-chair of the PFD for local authorities; represent PLATFORMA at
 relevant meetings and conferences in Brussels and occasionally abroad; facilitate the participation of
 members in events of the European institutions;
- Monitoring of partners' activities: ensure smooth communication with relevant project partners; monitor closely the progress of partners' activities in line with the foreseen budget; support project partners in the delivery of their own activities.

- You have at least 3 years' experience in development cooperation and understand the role and functioning of local and regional governments in this area;
- You are fluent (written and oral skills) in English and another EU language;

- You have good knowledge of the European Union policy-making and decision-making processes;
- You are able to work independently with minimal supervision;
- You have excellent critical thinking and problem-solving capacity;
