



CEMR ACTIVITIES IN SEPTEMBER AND OCTOBER 2012

SEPTEMBER

01/09: CEMR has released two **new publications**. The first, available in English, French, German and Spanish, presents CEMR's mission and its five new thematic domains. The second one, entitled *Local and Regional Governments in Europe – Structures and Competences*, outlines the organisation and functioning of municipalities and regions in 39 European countries. 14/09: Dexia Crédit Local and CEMR published a note entitled "*Sub-national public finance in the European Union in 2011*", which analyses the **financial situation** of local and regional governments. The study shows that efforts led by local authorities to optimise earnings and to better control expenses helped consolidate the budgetary balance in the EU sub-national public sector. 14/09 (Brussels): CEMR stressed the importance of community-led local development in the new **cohesion policy** as well as the need to reinforce provisions for partnerships between the local, regional and national levels. ⓘ Such was expressed by Angelika Poth-Mögele, CEMR director of policy, during a structured dialogue meeting held with representatives from the EU institutions, local and regional government associations, municipalities, regions, economic and social partners and civil society. 14/09 (Brussels): The CEMR "Energy efficiency" focus group met for the last time to analyse the final provisions of the directive on **energy efficiency**, adopted by the European Parliament on 4 October 2012. Participants welcomed the fact that the final text does not impose a binding annual target of 3% for the renovation of publicly owned buildings nor the obligation to purchase only goods or services with a high energy efficiency performance. ⓘ Contact: marie.bullet@ccre-cemr.org


19/09 (Brussels): The CEMR "**Air quality**" focus group met for the first time to discuss its main objectives, the first of which is to produce a position paper that puts forward strong messages. Participants agreed that public health should be at the heart of the group's work. They also agreed that locally-led measures for issues such as vehicle emissions should be a priority when revising the European legislative text relative to air. Contact: marie.bullet@ccre-cemr.org


20/09 (Brussels): Municipalities want to protect public health and offer a good-quality environment to their citizens, despite local investments being under pressure with the deepening of the economic and social crisis. 20/09 (*Brussels*): The draft directive on **service concessions** is too detailed and contains many elements specific to public procurement. The CEMR “Service concessions” focus group thus formulated amendments with the aim of creating a lighter regime and more flexible rules. Further objectives include an increase in the thresholds for goods and services as well as the exclusion of specific sectors, such as civil protection, emergency response, hazard prevention, water, energy and social services. 25/09 (*Cadiz*): The CEMR standing committee for **equality** and the national coordinators for equality-related issues from CEMR’s member associations gathered to discuss upcoming activities, including the work of the Observatory of the Charter for equality. A first draft of the Observatory website, which should be launched in January 2013, was presented at this occasion. 26/09 (*Cadiz*): Local and regional authorities need to act. The time for speeches and statements is over and the time to talk to national governments has come. Such was declared by Patrizio Fiorilli, spokesperson for the EU budget and financial programming, invited to address CEMR’s **Policy Committee** members. 26-28/09 (*Cadiz*): More interactive and innovative, the 25th **General Assembly** of European Municipalities and Regions brought together some 700 elected representatives and experts from 50 countries. 29/09 (*Cadiz*): Local and regional elected representatives adopted the **declaration of the 25th General Assembly** of European Municipalities and Regions. The text proposes a new approach to development, which relies on the ability of European territories to foster the right conditions for new growth. This growth needs to be sustainable and help create jobs via partnerships between political, economic and social stakeholders. 04/10 (*Brussels*): CEMR’s main objectives for the new directive on **public procurement**, which are simplification and flexibility, have not yet been reached. Heide Rühle, member of European Parliament and shadow rapporteur for the parliamentary committee on the internal market and consumer protection (IMCO), has informed CEMR’s focus group that the negotiations between the different political groups have become increasingly difficult. CEMR

09/10 (*Brussels*): Local and regional authorities call on the European Parliament, rapporteurs on the new cohesion regulations and the Cyprus EU presidency to ensure that the partnership principle is truly strengthened in the upcoming negotiations on **cohesion policy**. 10/10 (*Brussels*): The negotiations on **cohesion policy** and **innovation** in municipalities and regions are among the top priorities of the new CEMR "Sustainable territorial and local development" thematic platform. The platform met for the first time in order to establish a calendar and objectives for the coming months. A meeting has notably been organised early December with members of European Parliament to discuss the future of cohesion policy in the framework of negotiations on the multi-annual financial framework.⁽ⁱ⁾ Contact: alessandro.proia@ccre-cemr.org

15/10 (*Prague*): In today's European social, economic and political crisis-ridden context, local and regional authorities as employers and trade unions have committed to strengthening the European sectoral **social dialogue** in the local and regional government sector. This commitment has been translated into a series of 12 recommendations, which are to form a European framework for action in key areas, identified during a final conference of the project "Future of the workplace".⁽ⁱ⁾ The project conclusions⁽ⁱ⁾ and a summary of the conference debates⁽ⁱ⁾ are available on the CEMR website. 18/10 (*Brussels*): The budget allocated to **public services** must be examined very carefully as their contribution can have a direct or indirect impact on Europe's future infrastructures. Such was the message underlined in a declaration adopted by CEMR and the other partners of the Public Services Employers' Forum ahead of the tripartite social summit on 18 October 2012.
