Brulocalis is the association representing and working for the local authorities in the Brussels-Capital Region, created and managed by them. Its main mission is to support the 19 Brussels' communes and local social centers (Centres Publics d'Action Sociale – CPAS) to fulfill their own missions to the benefit of the Brussels' citizens. Brulocalis' work focuses on three pillars: (legal) advice, (institutional) capacity building, and (political) lobbying. The advocacy work is multi-level: towards the regional, community and federal Belgian governments but also with international institutions; and sometimes together with its sister associations from the two other regions: Union des Villes et Communes Wallonnes (UVCW) and Vereniging van Vlaamse Steden en Gemeenten (VVSG).

## **Bridges of Trust**

Ukrainian City Delegations Embark on 8th Study Visit in Slovenia to Strengthen Local Governance



Ukrainian city delegations from Bibrka, Krynychansk, and Poliana embarked on their 8th study visit to Slovenia from September 11th to 15th as part of the "Bridges of Trust" project, led by the Council of European Municipalities and Regions (CEMR) in collaboration with the Association of Ukrainian Cities (AUC). This initiative, generously supported by the U-LEAD with Europe program, aims to foster inter-municipal cooperation and knowledge exchange to strengthen local governance practices.

explore various facets of Slovenian local governance, focusing on communal services, waste management, restoration projects, and the cultural landscape. The visit aimed to provide a deeper understanding of the Slovenian local governance system and decentralization, with a keen eye towards the reconstruction process and on adopting the best practices in the Ukrainian context.



The delegations explored the cities of Lenart, Logatec, and Puconci, engaging in dialogues with their Slovenian counterparts to share experiences and insights on effective governance. These exchanges fostered a mutual learning environment where both Ukrainian and Slovenian officials could benefit from each other's expertise.



The 9th study visit under the "Bridges of Trust" project took place in Sweden and the next one is set to take place in Spain, continuing the journey of knowledge exchange and collaboration among participating municipalities. These visits are expected to enrich further the pool of best practices available

to Ukrainian cities and regions, contributing to the ongoing development of local governance in the country. As Ukrainian city delegations return from Slovenia, they bring with them valuable insights and experiences that are poised to make a positive impact on their communities. The "Bridges of Trust" project remains committed to building stronger, more resilient municipalities in Ukraine through international cooperation and the sharing of innovative governance strategies.

### A chat with Daniela Godinho Lourenço

Daniela has been recently promoted to the position of Head of Administration and Finance. Daniela is a hard worker, and her journey to this role has been marked by dedication, expertise, and an unwavering commitment to excellence. We interviewed Daniela to celebrate her well-deserved success and gain unique insights into CEMR through the lens of who knows the organisation inside out.

#### Hello Daniela and congratulations for your promotion. What do you remember about your first day in the organisation?

Thank you for honouring me on the #1 issue of *Resonance*. The 1<sup>st</sup> day was quite symbolic, actually; it was Europe Day – 9 may 2016. What impressed me the most was the team's immediate and spontaneously warm welcome.

#### What will you look for when you interview a new candidate?

My opinion here: the interview is the moment to highlight the soft skills: will this person fit in the team and the organisation? Is she/he keen to learn and adapt? What are the major personality traits that are revealed?

#### How has been your experience as a woman in the organisation?

CEMR is a recognised supporter of equality, and this is undeniably true in the office as well. You may have noticed by now the number of women working in the organisation and holding management positions. Additionally, our conditions of remuneration are the same, regardless the gender. Equal pay for equal work.
